Dear Colleagues:

This is a clarification of my letter, dated February 27, 2008, concerning the roll forward of Fiscal Year 2007-2008 rates for providers who fail to complete Fiscal Year 2008-2009 rate setting spreadsheets by March 14, 2008.

This clarification applies to residential programs only. If a provider of residential services fails to submit a completed Fiscal Year 2008-2009 rate setting spreadsheet by close of business March 14, 2008, the Administrative Entity (AE) will review the Fiscal Year 2007-2008 spreadsheets. If the Fiscal Year 2007-2008 residential rates were based upon 97 percent, the AE will roll the Fiscal Year 2007-2008 residential rate forward to Fiscal Year 2008-2009 after a reduction of three (3) percent.

Providers of Non Residential and Day Program services who fail to submit a completed Fiscal Year 2008-2009 rate setting spreadsheet by close of business March 14, 2008, will have their existing Fiscal Year 2007-2008 rates rolled forward.

Dear Colleagues:

On November 7, 2007, I advised you of changes and revisions made to the Rate Setting spreadsheets for Fiscal Year 2008-2009. That letter also established a January 31, 2008 deadline for the submission of completed spreadsheets to the Counties/Administrative Entities (AEs).


It has come to our attention that all expected spreadsheets have not yet been submitted to the appropriate County/AE. Recognizing that any further delays may jeopardize the ability of the County/AE to review the spreadsheets, finalize rates, enter them in Home and Community Services Information System (HCSIS) and complete Fiscal Year renewal 2008-2009 Individual Support Plans (ISPs) in a timely manner, we are advising you of the following:

1. Rate Setting spreadsheets that have not yet been submitted must be forwarded to the County/AEs by **March 14, 2008**.
2. Rates for services included on completed spreadsheets submitted by the original deadline of January 31, 2008 are to be entered in HCSIS by **March 31, 2008**.
3. Rates for services included on completed spreadsheets submitted after January 31, 2008 but on or before March 14, 2008 should be entered in HCSIS by **April 30, 2008**.

In order to prepare Fiscal Year 2008-2009 renewal ISPs, approve them and authorize services prior to the start of the year, Counties/AEs are hereby instructed to roll forward the provider's service rate(s) from Fiscal Year 2007-2008 to Fiscal Year 2008-2009 **if a spreadsheet has not been submitted by the close of business on March 14, 2008**.

These instructions are intended to assure that every provider and county has a full year of HCSIS/PROMISE billing, without any gap in billing activity or delay in authorizing services, in preparation for the direct payment of Waiver services through Treasury, effective July 1, 2009.
